50th ANNIVERSARY OF THE BERWICKSHIRE CIVIC SOCIETY


The forebear of the Berwickshire Civic Society, the Civic Trust "for improving the urban and village environment of Britain" was inaugurated in July 1957. Following this 200 Civic Societies sprang up. Twenty years later there were 1200, largely spread through the network of Lord Lieutenants under whose aegis Earl Haig was approached for a Berwickshire initiative. After some initial meetings Lord Haig, himself a considerable painter with an eye for the beauty of the environment, called a meeting at Bemersyde in October 1970 when, under the guidance of the Scottish Civic Trust, the Berwickshire Civic Society was finally formed with a written constitution.

The objects of the Society were to promote and encourage the following by charitable means:

- 1. Stimulate public interest in and care for the beauty, history and character of the county of Berwickshire.
- 2. Encourage preservation, development and improvement of features of public and historical interest.
- 3. Encourage high standards of architecture and planning and to comment on plans.
- 4. Pursue these ends by means of meetings, exhibitions etc and accessing plans from the local authorities.

It soon became clear that the Berwickshire Civic Society fulfilled a real need particularly in light of reorganisation and the change from local to more centralised government, and in its 50 years of existence the Society has done a good body of work. It saved the Mouth Bridge at Hume from closure and dereliction, not to mention the innumerable occasions when the Society, with its watching brief, has noted and commented and often acted upon matters concerning the environment, including the appropriate siting of wind turbine developments in the Berwickshire countryside. The Society initiated the Keep Berwickshire Tidy campaign and its biannual Architectural awards with recent winners being the Luckenbooth in Coldingham and development at Birgham.

As the Society reaches its 50th anniversary, the constraints we have all faced with Covid 19 has given pause to our activities. It does however also give us to time to reflect on the role of the Society and how we could develop our activities to best serve our members and the broader Berwickshire community.
